### Memberships

With **90 members** we have slightly decreased from last year (115 in 2014) but maintained a similar number of members to previous years (92 in 2013 and 97 in 2012).

To date we have the following members:

- 1 sustaining
- 5 lab groups (inclusive of 25 members)
- 40 full
- 24 concession and
- 22 new/returning members (16 after 30<sup>th</sup> June)

Again there was a surge in new members relating to the conference.

### **Total Current Assets**

The opening balance of the AMS bank account was \$23,191.68 and the closing balance was \$27,282.55. The opening balance of PayPal was \$510.90 and the closing balance was \$5030.83.

Therefore, the total cash assets of the AMS as at June 30<sup>th</sup> 2015 was \$32,313.38.

#### Income

The membership income for the year was 5,798.35. We also had the 2015 conference income of \$12,160.00, giving a total of \$17,958.35 in income.

#### **Expenses**

The expenses included bank and PayPal charges of \$648.73, AMS AGM 2014 and 2015 conference expenses (including prizes) of \$3,681.69, website hosting and webmaster \$1,239.40, accountancy and auditing fees of \$504.00, AMS grant 2014 of \$2000, AMS Logo of \$751.31 and chorus call teleconferencing of \$522.42. This gives a total of \$9,347.55 in expenses for the year.

## Profit

The profit for the 2014-2015 financial year was \$8,610.80. This is significantly more than the profit from the previous year of \$2,798.70.

#### 2015 Conference

The 2015 conference was held in Canberra in conjunction with the ASM in July. The AMS handled all of the AMS registrations (including 1 and 2 day registrations and dinners) with a total income of \$15,910.00. The total expenses including payment to ASM, catering, plenary airfares and prizes was \$11,675.62. There was a profit of \$4,234.38.

## Audit

The accountant Jim Alexander has completed the audit for 2014-2015. The forms will need to be signed today.

# **Summary**

We are in a good financial position to continue the AMS competitive grant. With a higher profit it may be possible to increase the grant amount or offer more than one grant this year. An alternative is to ask the council and/or members to propose uses for the profit to promote mycology in Australasia.
